## Why Spay and Neuter?

Allowing your pets to breed contributes to the pet overpopulation problem in Pierce and King Counties.

**ONE** female cat and her offspring can produce over **400,000 unwanted kittens** in **seven** years!

**ONE** female dog and her offspring can produce **65,000 unwanted puppies** in **seven** years!

Spaying and neutering your pet is a part of being a responsible owner. Having your pet spayed or neutered will not make it fat, lazy, or less protective. Having your pet sterilized benefits you, your pet, and the community. Most importantly, spaying or neutering your pet reduces the number of homeless animals unnecessarily killed in our local communities.

## What is SPOT?

SPOT is a low-cost Dog and Cat Spay/Neuter Program for low-income residents of Pierce and King Counties. The Community SPOT Program was developed by Auburn Valley Humane Society to address our community's pet overpopulation problem and to provide Spay/Neuter services to pet owners, who otherwise can not afford it.

## How much does it cost?

Dog Spay 51-75# - \$95
Dog Spay 76-100# - \$115
Dog Spay >100# - \$130
Dog Vaccine - DA2PPV - \$10*
Dog Vaccine - Bordetella - \$10*
Dog Vaccine - Rabies - \$10*
Dog Vacc - DA2PPV/Bordetella/Rabies Combo - \$30*

\* Additional services are available only with scheduled surgery.

## Who qualifies?

If you are receiving federal or state financial assistance or otherwise meet the Federal Poverty Income Guidelines.

## How do I apply?

Complete one application for each pet you wish to receive services.

Bring your completed application to:

along with proof of income or financial assistance and your co-payment.

**Fees are transferrable but non-refundable.**  
**Must use the voucher within 60 days.**

## What are the benefits?

- Your pet will not produce litters of unwanted puppies or kittens
- Your pet is less likely to roam or run away
- Your pet is less likely to bite
- Your pet is less likely to fight with other animals
- Your pet will be more calm, affectionate and overall, healthier
- Your pet will be less likely to spray or mark their territory
